

### C. Glenn Cobbs: Physician, Scientist, Leader

C. Glenn Cobbs was born in Birmingham, attended the University of the South and graduated Cum Laude from Princeton University in 1955. For the following three years, Dr. Cobbs served in the United States Marine Corps, then attended medical school, initially at the University of Alabama School of Medicine and then for his last two years at Harvard Medical School, from which he graduated in 1963. Dr. Cobbs served as a resident in medicine at what would become the University of Alabama at Birmingham and then completed a fellowship in Infectious Diseases at New York Hospital, Cornell Medical Center.

Dr. Cobbs returned to UAB in 1968 to serve as the first director and only faculty member of the Division of Infectious Diseases. During his tenure as director from 1968 until 1990, Dr. Cobbs recruited additional faculty,



trained many fellows, and built the program into one of the strongest divisions of infectious diseases in the country. He envisioned the concept for a specialty program in geographic medicine, and recruited Dr. Bruce Greene as its first leader.

Upon relinquishing the administrative leadership of the Division of Infectious Diseases, Dr. Cobbs assumed the position as Chief of Medical Service for the Birmingham Veterans Administration Medical Center, which he held until his retirement in 1999. He holds the rank of Professor Emeritus on the UAB faculty.

Dr. Cobbs has been a visiting lecturer at numerous academic medical centers and is a highly productive clinical investigator who has made major contributions to the understanding and management of infective endocarditis and other intravascular infections.

More importantly, Dr. Cobbs has been an exemplary role model as a physician educator who has demonstrated unwavering commitment to education at the bedside and in the conference room and has continually reminded the administration of UAB of the absolute importance of education as one of the three legs of the traditional academic stool. During his years at UAB, he trained and mentored more than 40 fellows, more than half of whom have pursued careers in academic medicine, and many of who are considered international leaders in the field.

In 2000, the UAB Department of Medicine established an annual Award for Clinical Excellence named jointly for Dr. Cobbs and his colleague Edwin A. Rutsky, MD, from the Division of Nephrology.

Endowed faculty positions provide, in perpetuity, a valuable tool to recruit and retain premiere teachers, clinicians and researchers – forever influencing the quality education provided to our students and the care accorded to our patients.


