

MSN NEW STUDENT INFORMATION

OSHA TRAINING:

At time of registration, you will register for **34179-NUR 004-QL** in addition to your spring 2012 courses as outlined on your Program of Study. This course is 0 credit hours, it will not be graded, and you will not be charged tuition.

1. To register for the course, refer to "Attachment E" that was sent to you in your admit packet.

HIPAA TRAINING:

Required once by ALL UAB School of Nursing students; if you are or have been an employee at UAB you have already completed HIPAA Training. You must already be registered for classes in order to complete this training. Follow these instructions to complete your HIPAA training:

- 1. Log into BlazerNet using your BlazerID and password
- 2. You can get to the training by clicking on the link here: http://blazernet.uab.edu/cp/render.userLayoutRootNode.uP
- 3. Click on the Courses & Training tab
- 4. Select the "UAB HIPAA TRAINING" action
- 5. Complete the HIPAA training session
- 6. Once you have completed the training session, please print out your Training Completion Certificate and keep it for your records
- 7. Your successful completion will be sent electronically to the School of Nursing

ORIENTATION:

MSN Orientation is an online course you will register for in addition to your spring 2012 courses as outlined on your Program of Study. You will register for **34178-NUR 001-QL**. This course is 0 credit hours, will not be graded, and you will not be charged tuition; however, this course is required by the School of Nursing. Please note the following in regards to MSN Orientation:

- 1. To register for the course, refer to "Attachment E" that was sent to you in your admit packet.
- 2. *IMPORTANT:* You will have completed Orientation once you take and submit the quiz at the end of the course.
- 3. MSN Orientation will open December 26, 2011 and the deadline for completion is January 17, 2012.

REGISTRATION:

At this step in the admission process, you should be underway or have finished with your registration. In order to register, you must be medically cleared, completed your drug screen and background check, returned your acceptance letter, program of study, and FERPA documents, and be clear of any holds on your account. You must have also created a BlazerID.

Please note that you will be charged with a late registration fee if you do not register by the January 9th deadline.
