As a young athlete and self-proclaimed tomboy, Allison Stephens was naturally drawn to a career involving athletics, coaching, exercise, and recreation. But it wasn't until she was in college at Samford University, studying Exercise Science and Sports Management, while also playing collegiate Women's Volleyball, that she began thinking of these disciplines in the context of physical rehabilitation.

Allison's college roommate suffered a serious accident leading to a high-level spinal cord injury. As her friend went through the rehabilitation process, Allison wanted to learn more, and ultimately completed an internship at Lakeshore Foundation. That early exposure to the benefits of exercise and recreation for

people with physical disabilities led Allison to a fitness and aquatics instructor position at St Vincent's Bruno Rehab Center. She later returned to Lakeshore Foundation as Coordinator of Fitness Programs, as well as Employee Wellness Coordinator for HealthSouth Lakeshore Rehabilitation Hospital and Southern Progress Corporation. This allowed her to oversee the fitness facility, and to coach wheelchair basketball, teach aquatics, and assist with outdoor adventure and recreational programs.

Allison moved to California in 1999 where she worked as a personal trainer, but ultimately returned to Birmingham and started Functional Fitness, a personal training practice for clients with and without disabilities, including some from Lakeshore Foundation programs. Among those clients was Michael E. Stephens, the founder of Lakeshore Foundation, who had suffered a spinal cord injury early in his career. Mike's vision for the Foundation created a continuum of care to serve individuals with disabilities at every stage of recovery, providing much-needed exercise, recreation, and competitive athletic opportunities for those dealing with physical challenges. The like-minded pair eventually became a couple and were married from 2011 until Mike's death in 2017.

Allison joined the Lakeshore Foundation Board of Directors in 2019 and is committed to continuing and helping to expand upon Mike's vision. She was co-chair of the Steering Committee for Lakeshore's recent \$17 million Capital Campaign. She serves on the Executive Committee and chairs the Strategic Planning Committee, where her experience as a trainer, coach, friend, and family member of individuals with disabilities continues to reap benefits for Lakeshore and its constituents. Allison also served on the Leadership Transition Committee as Lakeshore Foundation searched for a successor to their longtime CEO.
