Once an individual has met all the requirements of a state-approved teacher preparation program and becomes a program completer, the individual is no longer classified as enrolled.

In addition to meeting numerous professional standards and learning outcomes related to teaching students with disabilities effectively and participating on IEP teams, our special education candidates must demonstrate that they are able to teach students with disabilities effectively through the completion of impact on student learning projects completed during their methods courses and student teaching experiences. Additionally, these candidates participate in several courses taught on-site in area schools in which their faculty instructors use a scaffolded approach to demonstration teaching (i.e., instructor demonstrates an evidence-based strategy, the student models the strategy with corrective feedback, and then the student practices the skill independently under supervision). Our special education candidates also take a course on writing IEPs and as a part of this course, they must participate in authentic IEP meetings in area schools. Finally, throughout their courses and student teaching experiences, our special education candidates must complete an electronic portfolio in which they demonstrate competence in all of these areas.
