## PRINTING YOUR I-94

After your entry in the US, the U.S. Custom and Border Protection issue an electronic *Lawful Record of Admission* called **I-94** (no paper will be given to you). You can print copies of this I-94 online.

- Go To https://i94.cbp.dhs.gov/I94/#/home
- Click on the tab "Get Most Recent I-94"
- Consent & Continue
- Enter the required information as they appears on your passport
- Print a copy

NOTE – if you encounter problems retrieving your I-94 OR if any information (name, type of visa etc.) is incorrect, please contact ISSS immediately.

An I-94 form is needed by all persons except U.S. Citizens, returning resident aliens, aliens with immigrant visas, and most Canadian citizens visiting or in transit. Air and Sea travelers will be issued I-94s during the admission process at the port of entry.
