I understand and am aware that these exercises described herein will be conducted without shoes and bare foot. I am voluntarily participating in these activities and using all the equipment, suspension equipment and machinery with knowledge of the dangers involved. I hereby agree to expressly assume and accept any and all risks of injury or even death.

I do hereby further declare myself to be physically sound and suffering from no condition, impairment, disease, infirmity or other illness that would prevent my participation or use of all equipment, suspension equipment and machinery. I do hereby acknowledge that I have been informed that a medical evaluation is advisable before participation in an exercise/fitness activity or in the use of all exercise equipment, suspension equipment, dumbbells and machinery. I acknowledge that I have either had a physical examination and have been given my physician's permission to participate, or that I have decided to participate in activity and use of all equipment, suspension equipment, dumbbells and machinery without the approval of my physician and do hereby assume all responsibility for my participation and activities, and utilization of all equipment and machinery in my activities. I understand it was my responsibility to fully inform True40 LLC, The University of Alabama and their affiliates, including trustees, employees and agents, of any physical condition or disability which would prevent or limit my participation in an exercise or physical conditioning program. <u>University of Alabama at Birmingham, and their affiliates, including its officers, employees and agents, as a result of injuries resulting from or relating to my participation in all exercise programs, conditioning programs, in any activities, or use of all equipment, suspension equipment or machinery.</u>
