The UAB Department of Pathology was well represented at the recent American Society for Investigative Pathology (ASIP) meeting

in Boston, Massachusetts. The meeting was held in conjunction with Experimental Biology 2013 and marked the Centennial Anniversary of the founding of the American Society for Experimental Pathology, ASIP's predecessor organization and one of the founding members of the Federation of American Societies for Experimental Biology (FASEB). Approximately twenty UAB faculty, post-doctoral fellows, graduate students and staff attended the ASIP Centennial Reception and Dinner held at the Institute

of Contemporary Art on the Boston waterfront, representing the single largest institutional contingent at the celebration.

The American Journal of Pathology (AJP) is the official journal of the ASIP and the most frequently cited journal in the discipline of pathology. I was recently appointed the AJP Editor-in-Chief (EIC) following in the footsteps of our previous Chair of Pathology, Dr. Jay McDonald who served as EIC from 2003-2008. Dr. McDonald was ably assisted during his tenure as AJP EIC by Senior Associate Editor, Dr. Gene Siegal who subsequently became EIC of Laboratory Investigation, another outstanding pathology journal. Drs. John Chatham and Robin Lorenz have been appointed as AJP Senior Assistant Editors

and Ms. Angela Schmeckebier as Editorial Assistant. I am confident that with this highly capable editorial team at UAB, the Journal will further enhance its reputation as an international leader in scientific publishing.

In total, the UAB Department of Pathology has established itself as a leader in experimental pathology research and education and I look forward to our future discoveries.

Faculty Profile: Robin G. Lorenz, M.D., Ph.D.



Dr. Lorenz received her B.S. in Biological Sciences from Stanford University. She attended Washington University

School of Medicine as a Medical Scientist Training Program Fellow and received her Ph.D. in Immunology and M.D. in 1990. From 1990 to 1994 she was a resident in Laboratory Medicine (Clinical Pathology) at Barnes Hospital. From 1994-2002 she was an Assistant Professor in the Departments of Pathology and Medi-

cine at Washington University. In addition to directing a basic science research lab focused on chronic inflammation in the gastrointestinal tract, she was co-director of the Joint Clinical Immunology Laboratory of Barnes-Jewish Hospital and St. Louis Children's Hospital, and Associate Director of the Laboratory Medicine Residency Training Program.

Dr. Lorenz joined the University of Alabama at Birmingham faculty in 2002 in the Departments of Pathology and Microbiology. The

National Institutes of Health the Juvenile Diabetes Foundation, and the Crohn's and Colitis Foundation fund her laboratory research investigating the mucosal immune system. She has served as the Chair of the MD/PhD Section of the AAMC Graduate Research, Education, and Training (GREAT) Group. She is also a member of the NIH NIGMS Training, Workforce, Development and Diversity (TWD) Study Section. At UAB, her administrative duties have included being the Associate Director of the Pathology Residency Program, and

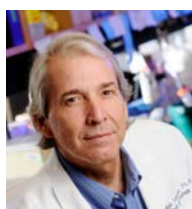


Shannon Bailey and Uduak Udoh, Division of Molecular and Cellular Pathology attended the Keystone Symposium on "Molecular

Zdenek Hel. Nathan Bowers, a graduate student in Dr. Hel's lab, was awarded with a National Institute of Allergy and Infectious Disease Scholarship to attend the Keystone Symposium on Immune Activation in HIV Infection and was selected for an oral presentation in the main session.

Dr. Hel's Endocrinology publication - Huijbregts, R. P. et al. Hormonal contraception and HIV-1 infection: medroxyprogesterone acetate suppresses innate and adaptive immune mechanisms – was accompanied with a highly favorable introductory comment article, a research highlight in Nature Reviews Endocrinology, and an interest by independent media.



Yi-Ping Li's lab recently published a paper entitled "C/EBPα is the Key Regulator of Osteoclast Lineage

Commitment" in Proc Natl Acad Sci U S A. PNAS, on April 11. Current osteoclast inhibitors used to treat osteoclast-related bone diseases display the negative side effects (e.g. jaw osteonecrosis and increased bone fragility). Their study demonstrated that C/EBPα is the Key Regulator of Osteoclast Lineage Commitment from monocyte/macrophage cells to osteoclasts cells. They also found that C/EBPα as novel therapeutic targets can regulate bone formation also. These discoveries establish C/EBPα as a key transcriptional regulator that regulates both bone resorption and formation synchronously, providing a unique therapeutic target for diseases of excessive bone resorption such as osteoporosis and arthritis.

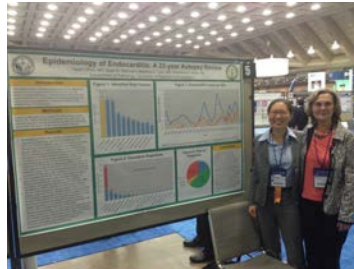
