# Faculty receive honors for their commitment to disability support

Disability Support Services has awarded two university employees for their work in supporting students with disabilities on campus. Each year, select faculty and staff are recognized by students and DSS staff for their exceptional efforts toward providing accommodations and helping to foster an inclusive campus. The Spring 2019 winners are Vladimir Parpura, M.D., Ph.D., a professor in the Department of Neurobiology in the School of Medicine, and Amy W. Evans, executive director of Administrative Operations in the College of Arts and Sciences.

Parpura received the Outstanding Faculty Award. He was nominated by one of his students who highlighted the ways in which he supports and challenges students with disabilities. "Dr. Parpura is my next example as to how I should conduct myself in society. His humility and respect for people are things I will strive to have as I become a professional. I am truly glad to have met Dr. Parpura as he has and will continue to be a great influence on my life," one of Parpura's students stated.

Parpura promotes an inclusive classroom environment by catering to diverse learning styles. His student reported, "Dr. Parpura is not only just a great professor he is genuine and an amazing person. He provides multiple ways as to which material is presented as well as different learning opportunities. For instance, he used lecture-style and hands-on teaching throughout the course in the lab and in the classroom."

DSS's second honor, the Outstanding Recognition Award, went to Evans. She was integral in ensuring all faculty and staff members within the College of Arts and Sciences participate in DSS's online training, an effort that was mandated by the CAS's Dean Robert E. Palazzo, Ph.D.

"Amy spent significant time over the last academic year collaborating with DSS to ensure the College of Arts and Sciences was actively involved in supporting students with disabilities at UAB. Amy coordinated with the DSS office to schedule training sessions for new faculty as well as department chairs. Amy was also integral in helping implement Dean Palazzo's mandate for all College of Arts and Sciences faculty and staff to complete the online DSS training," a DSS staff member reported.

DSS, through student nominations, selects faculty and staff members to honor each semester who have gone above and beyond to support students with disabilities on campus.

# Captioning in Canvas:

Here are some things you should know!

There are two types of video captioning available in Canvas: machine and professional. Machine captioning is around 80 percent accurate and can be edited to increase accuracy. Please note that machine captioning does not meet the needs of students who are approved for video captioning as a DSS accommodation.

Professional captioning is more

accurate and can be requested via the <u>UAB Disability Support Services request form.</u> Professional captioning is strongly recommended by DSS for all course videos and is the required method of captioning when a student in the course is approved for captioning as an academic accommodation.


Did you know there are accommodations available to students for extended time on in-class assignments?

DSS currently has 130 students who are approved for the accommodation "extended time on in-class assignments." This accommodation generally applies to shorter, timelimited class assignments, rather than assignments that are open for several days or weeks. The accommodation



applies to lecture-style courses as well as online courses. DSS encourages faculty members to meet with students who are approved for this accommodation early in the semester to ensure the instructor and the student are on the same page about how the accommodation will apply. 
#### Study skills workshops scheduled

# Learn more about what Canvas has to offer

DSS would like to thank Jerad Watson, Instructional Technologist in the Division of eLearning and Professional Studies, for providing answers to frequently asked questions about using Canvas.

How do I extend time on a timed exam for a student without



#### interrupting their testing process?

Instructors can give extra time to a particular student(s) before and even during the exam by moderating the Canvas Quiz. Follow the directions below.

- 1. Access the Quiz in Canvas and click Moderate This Quiz.
- 2. You can then search for the desired students and check the box beside their names.
- 3. Click the pencil icon that says Change Extensions for Selected Students at the bottom.
- 4. You can then enter the amount of Extra time the student(s) should get in addition to the already allotted time.
- 5. Click Save.

## How do I change the due date or exam availability dates for a particular student?

Instructors can assign a different due date or exam availability dates for desired students without impacting the rest of the class by adding another Assign Card. Follow the directions below.

- 1. Access the Quiz in Canvas click the Edit Pencil the top right and scroll down to the bottom of the Quiz Details page.
- 2. Click +Add underneath the Assign Card to add another Assign Card.
- 3. Type the names of the desired students you are wanting to modify the dates for.
- 4. Type in the Desired Due Date, Available from the date (when students can access the exam), and Until date(when the exam will no longer be available).
- 5. Click Save.

Note: this same process can be completed for all types of Canvas Assignments

#### How do I create an active syllabus on canvas rather than just text?

The Syllabus feature in Canvas has two parts. Top and bottom. Click the Syllabus tab in the course navigation then click the "Edit Pencil" at the top right to add your syllabus.

The top section allows the instructor to provide text and link files. We recommend having a short summary of important information from your syllabus such as your contact information and grading policies then <u>providing a link to your full syllabus in PDF format.</u>

The bottom portion is automatically generated based on Assignments and Events created in the Canvas course. This portion is important as it allows students to see on the Canvas calendar what assignments they should be working on and their due dates.

In order to populate this section of the syllabus, instructors must add assignments or events to the Canvas course and publish them.

Having both the top and bottom sections completed creates what is called a Dynamic Syllabus.

#### Legal Roundup

Case: Letter to Drake University, No. 05-17-2039 (OCR 04/28/17)

Student was enrolled in Drake University's Doctor of Pharmacy program and was also registered as a student with a disability and was approved for academic adjustments by the university. The Doctor of Pharmacy program required four years of classes, during which students were required to

maintain a grade of "C" or higher in all courses. Students were expected to complete their didactic course work within the first three years of the program but could extend the coursework into a fourth year when necessary. Students who did not meet these requirements were dropped from the program.

During his second year of classes, Student was granted approval to withdraw from a required course and reduce his course load for his remaining time in the program. Student was notified that this modified schedule would make it more difficult for him to complete all required courses within the four-year time limit. Student subsequently received a grade of "F" for one of his required courses. The student requested an exception to the program's four-year time limit policy but was denied. The university contends that the student's disability status was not taken into consideration when determining whether an exception to policy would be appropriate. The university requested to enter into a resolution agreement prior to the conclusion of OCR's investigation.

**Resolution:** The university must revise its academic adjustment policies to require the interactive process when a student with a disability requests a policy modification as a disability accommodation. The university must notify students, faculty, and staff of this policy change, and train faculty on the revised policies. The university must also engage in the interactive process with the student to consider his policy modification request. Should the university

grant the student's request, the university must remove the grade of "F" from the student's transcript.
