1	WHEREAS the University of Alabama at Birmingham Undergraduate Student

5	WHEREAS it is the duty of the USGA to lead the undergraduate student body towards

11	WHEREAS currently Senators may only pass and discuss bills, resolutions, and

35	require a majority vote of the Senate in special sessions or formal meetings;" and
